DOMESTIC SHIPPING INSTRUCTIONS Revised February 1, 2019

The following supplier routing instructions are to be adhered to when EaglePicher® Technologies is responsible for the freight charges. These instructions supersede all previous instructions, either written or verbal, unless other instructions are expressly noted on EaglePicher's Purchase Order. EaglePicher reserves the right to debit Supplier's Account for all excess and administrative costs incurred through supplier's failure to comply with these instructions.

EaglePicher Purchase Order Number(s) must be referenced in the "Shipper Reference" or "Billing Reference" area of all bills of ladings, air bills and on all shipping labels, packing lists and invoices. No prepaid and adding of freight, pickup or handling charges of any kind will be paid or allowed on Supplier's Invoice unless expressly called out on the EaglePicher Purchase Order.

Shipping by other than what is specifically stated in the Purchase Order (i.e. different carrier or service level such as: air versus ground or next day versus 2nd day) must be approved by EaglePicher Purchasing Department *ONLY*.

THIRD-PARTY DROP SHIPMENTS

1. Bills of Lading for "Drop Shipments" from one supplier to a second supplier, where neither the shipper nor consignee is EaglePicher, must be marked for "THIRD PARTY BILLING" of freight charges to:

No prepaid and adding of freight charges of any kind will be paid or allowed on Supplier's Invoice unless expressly noted on EaglePicher purchase order.

- SHIP TO address must be marked as to "EaglePicher Technologies LLC" C/O the second suppliers name and address. EaglePicher Purchase Order number(s) must be referenced on all freight bills, airbills, shipping labels, packing slips and invoices.

Insurance: EaglePicher Technologies is self-insured. Do not insure or declare a value for carrier insurance regardless of mode of transportation. Charges billed by carriers for insurance will be debited from supplier's invoice. **Declared or Released Value:** On Truck shipments subject to declared or released value ratings, shipper shall declare that value which results in the lowest transportation charges.

Multiple Shipments: When tendering more than one shipment to the same carrier on the same day, consigned to the same delivery address, where the same mode of transportation (air or surface) was specified; consolidate all shipments on one bill of lading, air bill, or other shipping document.

Marking of Package: <u>EaglePicher Purchase Order number(s)</u>. If no Purchase Order number is given, name of person and department to receive shipment must be indicated on the shipping label, bill of lading or airbill. In addition, the Purchase Order number(s) must be shown as the shipper's reference number on all shipping documents. Shipper and consignees complete shipping address must be included. No PO Box addresses.

Hazardous Materials: Shipments containing hazardous materials must be in compliance with the D.O.T. regulations under the 49 CFR, and IATA. The packaging, labeling and preparation of shipping documents must be in accordance to these regulations. If you are unable to use UPS for a Hazardous Material shipments, please call for routing instructions.

Air-Ride & Padded Van Shipments: Contact EaglePicher Logistics Office 3-5 days in advance of ship date at 417-623-8000 ext 619 or 411.

For Oversized Truck Load, Bulk Tanker or Refrigerated: Contact EaglePicher Logistics Office for special carrier routing and shipping instructions 3-5 days in advance of ship date at 417-623-8000 ext 619 or 411.

C.O.D.: C.O.D. shipments must be negotiated by the Purchasing Department and approved prior to shipment. C.O.D. shipments must ship direct to an EaglePicher facility.

Consolidate: Consolidate items shipped on same day to the same destination on one airbill or bill of lading.

Packaging: Suppliers will contact their EaglePicher procurement agent for a copy of the latest packaging instructions if required.
